OPENING: TWO PEOPLE DISCOVER THE BODY. WE GOTTA CALL LAW & ORDER

DETECTIVES: TWO DETECTIVES DISCOVER EVIDENCE ON THE BODY

PEOPLE OF INTEREST 4 SCENES: DETECTIVES INTERVIEW PEOPLE WHO KNOW THE VICTIM. THIRD SCENE IS WITH THE MURDERER.

LIEUTENANT SCENE: DETECTIVES ACCUSE PERSON FROM SCENE 1, 2 OR 4. DETECTIVES MAKE THEIR CASE. LIEUTENANT TELLS WHY THEY ARE WRONG AND GIVES EVIDENCE POINTING TO THE MURDERER.

INTERROGATION: DETECTIVES & THE MURDERER. SAVED BY THE ATTORNEY. LIEUTENANT JUMPS IN. RIPS THEIR FAILURE. SENDS THEM TO THE MEDICAL EXAMINER

MEDICAL EXAMINER: EXAMINER & DETECTIVES. DISCOVERS NEW EVIDENCE IN OR ON THE CORPSE THAT POINTS TO THE MURDERER

PUBLIC ARREST: MURDERER & DETECTIVES. EVERYONE ELSE FILLS OUT SCENE.

ORDER PART

INTRODUCE THE DEFENSE & JUDGE: DA & ADA TALK ABOUT THE CASE EACH CHARACTER PAINTS ONE OF THE DEFENSE ATTORNEY & JUDGE.

BAIL HEARING: JUDGE, ADA, DEFENSE, MURDERER IN COURT SETTING. ABSURD OVER HEIGHTENING OF EACH SIDE THEN REMAND.

DEBATE THE CASE: ADA & DA ARGUE ABOUT WHAT CHARGES TO PURSUE. DA FOLKSY MONOLOGUE. AUDIENCE MEMBER DELIVERS DEFENSE MOTION TO DISMISS.

MOTION TO DISMISS: ADA, DEFENSE & JUDGE ARGUE THE MOTION. IT IS DISMISSED.

PLEA BARGAIN: ADA, DEFENSE & MURDERER. ABSURD HEIGHTENING.

TRIAL: ADA, JUDGE, DEFENSE, MURDERER, OTHER FOLKS PLAY WITNESSES. LINE IN POCKET OPENING STATEMENTS. JUDGE LETS AUDIENCE CHOOSE TWO WITNESSES. WITNESSES INTERVIEWED, THEN MURDERER INTERVIEWED. JUDGE GETS TWO WORDS FROM AUDIENCE. JUSTICE IS LIKE . . . CLOSING STATEMENTS. JURY VOTES.
